## **New Business**

Amanda would like to develop a maintenance plan for trails. We have money in budget and would like to see 5-year plan. We had to have a number for grant proposal. Dave will look and let us know.

Dave – finalizing easement negotiations with Grand Rapids Gravel and the Reagen property. MDOT money comes from fed government. We have to follow very strict procedures. Need to have a good faith offer to property owners for easement. Process has become stricter in the last year or so. Cannot go to assessor office now to get worth. Need to hire professional to value property and get comps, etc.

Permitting with EGLE. Had meetings with hydraulics analysis. Will not impact flow of Grand River. When you get south of Stoney park, cross with culverts. Cannot do that so

now we need to install 150' bridge. More complicated analysis. Proposing prefab bridge. Assembled offsite. 2 pcs.

MDOT – schedule to protect grant. Required quarterly reporting. Keep in touch so they understand and they don't give away money.

DNR real estate office – phase 2. Get right of way from railway. Still waiting to hear back.

Still need Vergennes representative for LARA. Other board members will put out the word also.

Website review - check website for updates brought up at previous meeting. Perry would like to go thru website again at next meeting. 30 mins. Have Jordan do updates before next meeting and then go thru it in November. Janine will follow up with Jordan to come to November meeting. Also discuss IT needs with Kore Hi Com.
